## Lea County Electric Cooperative, Inc. **Application for Membership and Service**



Welcome to Lea County Electric Cooperative, Inc. (LCEC). We value your business and look forward to meeting your energy needs. We are committed to providing you with the best service, quality and reliability.

The undersigned (hereinafter called the "applicant") hereby applies for membership in, and agrees to purchase electric energy from LCEC (hereinafter called the "Cooperative), upon the following items:

- 1. If the applicant is approved by the Cooperative, a) the applicant shall pay the Cooperative, the sum of \$5.00 which sum shall constitute the applicant's membership fee, and (b) the applicant shall satisfactorily establish credit to secure payment for electric service, or, if such credit has not been established satisfactorily to the Cooperative, shall make a utility deposit, all in accordance with the terms and hereafter by its Board of Trustees.
- 2. A Social Security Number (SSN) or Federal Identification Number (TIN) is required to apply for membership/electric service.
- 3. New or re-connects will be activated by the end of the next business day that application is made by applicant.
- 4. Applicant, or applicants if joint, may contact the Cooperative by phone or in person to inquire about the account. To protect the applicant (s), no information will be disclosed until the applicant(s) can identify himself/herself with the last four (4) digits of the social security numbers of applicant(s).
- 5. Delinquent accounts shall be referred to a collection agency.
- 6. The applicant shall furnish to the Cooperative any Rights-of-Way, which may be necessary in the opinion of the Cooperative for the construction, maintenance and operations of necessary electric facilities, to service the applicant's premises described below.
- 7. The applicant shall, when electric energy becomes available, purchase from the Cooperative all electric energy used on the premises described below and shall pay thereafter monthly, when the same shall become due and payable, the rates which shall from time to time be fixed by the Cooperative's Board of Trustees, including any minimum bill per month which may be specified herein, regardless of the number of kilowatt hours consumed; any demand fees; and such rates being approved by the appropriate regulatory agency having jurisdiction over the service, rates or charges of the seller.
- 8. The Cooperative shall not be liable to the Applicant or any other person if it is unable to supply electric energy to Applicant or such supply shall be interrupted or defective through failure or breakdown of Cooperative's supply of electric energy from its supplier or if such failure or interruption or defective condition is caused by failure or breakdown of Cooperative's facilities or by strike, necessary repair of its facilities, labor disturbance, riot, act of God, by accident, the elements, inability to secure right-of-way, or other permits, or authority necessary to provide the same, prohibition by legal processes, direction of any governmental agency or by any other cause beyond the reasonable control of the Cooperative.
- 9. The applicant will cause his premises to be wired in accordance with wiring specifications approved by the Cooperative. The applicant's metering point is approximately \_\_\_\_\_ feet from the proposed distribution line of the Cooperative.
- 10. The applicant shall abide by and be bound by the provisions of the Articles of Incorporation and the Bylaws of the Cooperative, including any subsequent amendments to either of same, and by all of the Cooperative's rules and regulations, whether same are presently in force or are adopted from time to time hereafter by the Cooperative's Board of Trustees. Bylaws are posted on the Cooperative's website.
- 11. The acceptance of this application by the Cooperative shall constitute an agreement between the applicant and the Cooperative and the contract for electric service shall continue in force for \_\_\_\_\_ years from the date service is made available by the cooperative to the applicant and thereafter until cancelled by at least thirty (30) days written notice given by either party to the other.
